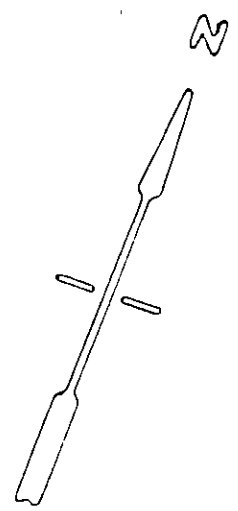
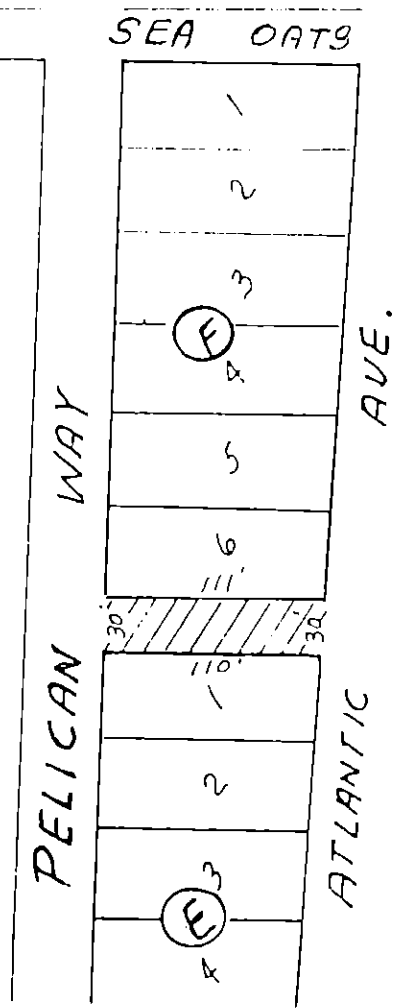
LEGAL DESCRIPTION

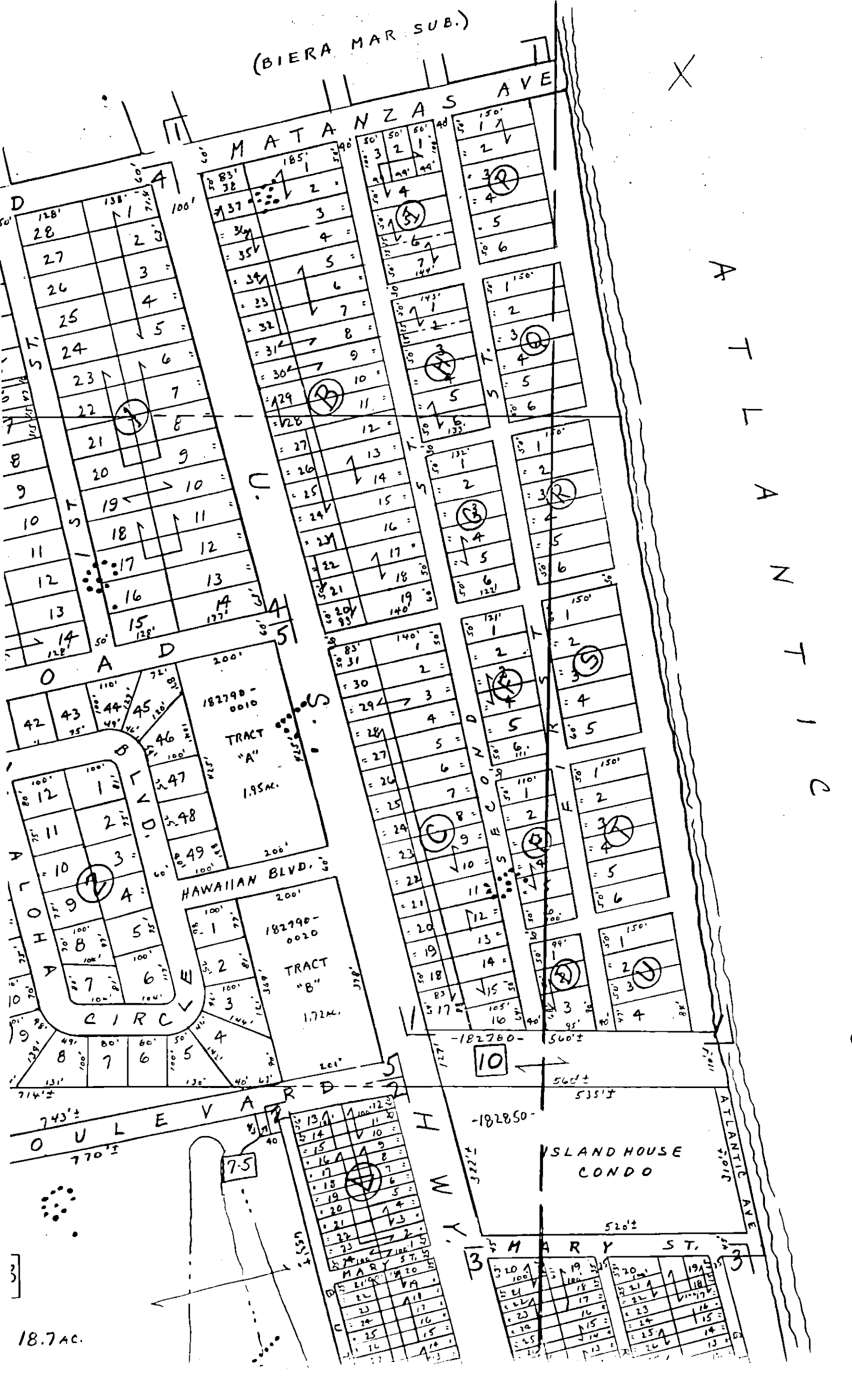
SCHEDULE "A"
