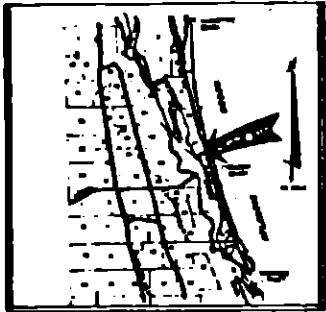

## SCHEDULE "A"

FROM THE POINT OF BEGINNING AT THE NORTHEAST CORNER OF LOT 25, BLOCK 3, TREASURE BEACH, 1st. ADDITION, RUN SOUTH  $70^{\circ}24'57''$  WEST, 63 FEET TO THE EAST LINE OF THE UN-NUMBERED LOT LYING SOUTH OF LOT 49, BLOCK 4, TREASURE BEACH 3d. ADDITION; THENCE SOUTH  $37^{\circ}19'44''$  EAST, 132.40 FEET; THENCE NORTH  $70^{\circ}24'57''$  EAST, 63 FEET ALONG THE SOUTH BOUNDARY OF TREASURE BEACH SUBDIVISION TO THE SOUTH WEST CORNER OF SAID LOT 25, BLOCK 3; THENCE NORTH  $37^{\circ}19'44''$  WEST, ALONG THE WEST LINE OF SAID LOT 25, BLOCK 3, 132.4 FEET TO THE POINT OF BEGINNING. BEING ALSO DESCRIBED AS THAT PORTION OF DESOTO ROAD LYING BETWEEN THE NORTH AND SOUTH LINES OF SAID LOT 25, BLOCK 3, TREASURE BEACH 1st. ADDN. EXTENDED WESTERLY TO THE EAST LINE OF SAID UN-NUMBERED LOT LYING SOUTH OF LOT 49, BLOCK 4, TREASURE BEACH, 3d. ADDN.
