

ST. JOHNS COUNTY RESOLUTION NO. 89-183

WHEREAS, St. Johns County ordinance 82-38 activated the St. Johns County Education Loan Authority (the Authority); and

WHEREAS, the term of office of Dr. William J. McClure as a member of the Authority has expired; and

WHEREAS, Dr. William J. McClure expressed a desire not to be reappointed to the Authority

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, as follows:

Section 1. John E. Wilson is hereby appointed as a member of the St. Johns County Education Loan Authority effective immediately and continuing to July 12, 1993 and until his successor is appointed.

Section 2. It is hereby found that John E. Wilson, is a trustee, director, officer or employee of an institution for higher education, as defined by the Higher Education Loan Authority Act, that is located in St. Johns County.


Section 3. This Resolution shall become effective immediately upon its adoption.




