

Resolution 90-160
American Red Cross - St Johns River Area Chapter

- WHEREAS, Ponte Vedra and the Ponte Vedra Beach Area is indeed a part of Johns County, and
- WHEREAS, all residents of this beforementioned area reside, pay taxes, vote, and elect representatives in St Johns County, and
- WHEREAS, all residents of the Ponte Vedra and the Ponte Vedra Beach Area are completely supported by all aspects of St Johns County Government, including: Education, Law Enforcement, Fire, Emergency Medical Services, Public Safety/Emergency Management, and
- WHEREAS, all residents of the Ponte Vedra and the Ponte Vedra Beach Area receive all services - Fire, Rescue, Police, and all others - from our own St Johns County, and
- WHEREAS, the American Red Cross has a vital role in the delivery of humanitarian and educational services to the citizens of St Johns County, and
- WHEREAS, the American Red Cross has a crucial role in assisting County residents and Government in time of disaster, and
- WHEREAS, the Board of County Commissioners of St Johns County believes that the St Johns River Area Chapter of the American Red Cross is in the best position to deliver cost effective services to the residents of the Ponte Vedra and the Ponte Vedra Beach Area - as well as the entire county of St Johns, and
- WHEREAS, this realignment of the American Red Cross boundary is in the best interest of our constituents, and
- WHEREAS, this realignment is vital to our citizens of St Johns in receiving Red Cross services, and
- WHEREAS, this realignment is fully supported by the County Government departments, including: Sheriff, Public Safety, Fire, Education, and
- WHEREAS, there is only one United Way that serves St Johns County and the St Johns River Area Chapter of the American Red Cross is a United Way Partner of this important service agency, and
- WHEREAS, the Board of County Commissioners of St Johns County finds no evidence to support any other division of the county of St Johns by any other chapter of the American Red Cross, and
- WHEREAS, the Board of County Commissioners of St Johns County believes that any division of the County of St Johns would not be in the best interest and would be

detrimental to the residents of St Johns County, and

WHEREAS, the Board of County Commissioners of St Johns County agrees with the aforementioned:

THEREFORE, BE IT RESOLVED: That the Board of County Commissioners of St Johns County, this 11th day of September, 1990 does hereby desire and fully endorse that the boundary of the St Johns River Area Chapter of the American Red Cross be the political, governmental, and physical boundaries of St Johns County - the St Johns/Duval county line.
