

RESOLUTION 91-10

A RESOLUTION OF THE ST. JOHNS COUNTY COMMISSION AUTHORIZING THE PONTE VEDRA AREA COUNCIL OF THE ST. JOHNS COUNTY CHAMBER OF COMMERCE TO APPLY FOR A HIGHWAY BEAUTIFICATION GRANT MEMORANDUM OF AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION AND AUTHORIZING THE COUNTY ADMINISTRATOR AND/OR HIS STAFF TO ASSIST THE PONTE VEDRA AREA COUNCIL OF THE ST. JOHNS COUNTY CHAMBER OF COMMERCE IN THE PREPARATION OF THE APPLICATION FOR THE APPROPRIATE GRANT AND AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION.

WHEREAS, St. Johns County desires to maintain roadside areas and median strips in an attractive and aesthetically pleasing manner, as is financial feasible; and

WHEREAS, St. Johns County desires to have as pleasing an entrance into the county as is financially feasible; and

WHEREAS, State Road 1A South of the Duval County line to just south of the intersection with CR 210 is such an entrance to the County that needs to set a precedent for the County; and

WHEREAS, the State of Florida Department of Transportation acknowledges the need and desire to create pleasing and aesthetically landscaped roadsides and median strips by its Highway Beautification Grant and its Highway Landscaping Maintenance Memorandum of Agreement; and

WHEREAS, the Florida Department of Transportation Highway Beautification Grant which is a fifty percent (50%) Cost Share Grant; and

WHEREAS, the Ponte Vedra Area Council of the St. Johns County Chamber of Commerce is willing to enter into a fifty percent cost sharing agreement to fund a beautification project with the County in the above described area; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of St. Johns County, Florida, this 22nd day of January, 1991.

Section 1. The St. Johns County Commission hereby grants, authorizes and otherwise directs the Ponte Vedra Area Council of the St. Johns County Chamber of Commerce to apply for the Highway Beautification Grant from the Florida Department of Transportation with the assistance of the County Administrator.
