

RESOLUTION NO. 95-11

A RESOLUTION PASSED PURSUANT TO ST. JOHNS COUNTY ORDINANCE NO. 85-29 AS AMENDED REQUIRING THAT THE CURRENT RECEIPT FOR THE REQUIRED DAILY FEE OR THE YEARLY SEASONAL FEE BE AFFIXED TO THE VEHICLE AND CONSPICUOUSLY DISPLAYED IN THE MANNER SET FORTH IN THIS RESOLUTION WHEN THE OWNERS OR DRIVERS OF THE VEHICLES ARE REQUIRED BY THE ORDINANCE TO HAVE PAID SAID FEE AND TO POSSESS A RECEIPT OF SAID FEE; REQUIRING THAT THE RECEIPT FOR THE YEARLY SEASONAL FEE BE PERMANENTLY AFFIXED; DEFINING PERMANENTLY AFFIXED; REPEALING RESOLUTION 85-46 AS PREVIOUSLY AMENDED; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 24 of St. Johns County Ordinance No. 85-29 provides that failure to possess a receipt for the required daily fee or annual yearly season fee shall be deemed a violation of the ordinance when such motor vehicle is located on the beaches within the jurisdiction of the applications of the ordinance; and

WHEREAS, Sections 7 and 14 of said ordinance provide that the Board of County Commissioners of St. Johns County may design appropriate procedures to collect the fee and provide for enforcement of the ordinance; and such procedures shall become effective upon passage of a Resolution by the Board setting forth such procedures; and

WHEREAS, numerous motor vehicle operators have in the past refused to conspicuously display required receipts while their vehicles are on the beaches, thus creating unnecessary difficulties in enforcing the ordinance and previous resolutions.

NOW, THEREFORE, BE IT RESOLVED this 24<sup>th</sup> day of January, 1995, by the Board of County Commissioners of St. Johns County, Florida, as follows:

**Section 1.** Resolution 85-46 as previously amended is hereby repealed and terminated.

**Section 2.** The current receipt for the required daily fee required by St. Johns County Ordinance No. 85-29 as amended shall be affixed to the inner front windshield of all motor vehicles in such a manner as to be conspicuously visible to passerby during all times in which the owners or drivers of such motor vehicles are required by said Ordinance to have paid said daily fee and to possess a receipt or ticket for said daily fee.

**Section 3.** The current receipt for the yearly seasonal fee required by St. Johns County Ordinance No. 85-29 as amended shall be permanently affixed to the inner front windshield of all motor vehicles in such a manner as to be conspicuously visible to passersby during all times in which the owners or drivers of such motor vehicles are required by said ordinance to have paid said fee and to possess a receipt or ticket.

**Section 4.** In the event the motor vehicle has no front window, the current receipt of the required daily fee or yearly seasonal fee shall be affixed to the vehicle in such a place as to be conspicuously visible to passersby during all times in which the owner or driver of such motor vehicle is required by the Ordinance to have paid said fee and to possess a receipt for said fee. The current receipt for the yearly seasonal fee shall be permanently affixed to such place.


**Section 5.** As used in sections 3 and 4 above, the words "permanently affixed" shall mean the affixing of the receipt by removing the protective covering from the adhesive material and placing receipt on windshield or other conspicuously place if no windshield.

**Section 6.** No such receipt shall be affixed in a location that will unduly obstruct the vision of the operator of the vehicle.

**Section 7.** This resolution shall take effect upon adoption.
