

RESOLUTION NO. 96- 61

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY APPROVING PAYMENT OF COSTS OR FEES OF THE COURT IN THE AMOUNT OF \$507.90 TO BRIAN DONAHUE.

WHEREAS, Florida Statute 939.06 requires that "[n]o defendant in a criminal prosecution who is acquitted...shall be liable for any costs or fees of the court"; and

WHEREAS, Florida Statute 939.08 requires that "an itemized bill or statement thereof shall be submitted to the county commissioners of the county in which such cases are prosecuted, and the same shall not be paid until the board of county commissioners shall have approved it..."; and

WHEREAS, defendant Brian Donahue paid costs in preparation for a criminal trial; and

WHEREAS, said Brian Donahue was found *not guilty* of the charge against him in County Court; and

WHEREAS, County Court Judge Charles Tinlin has certified that the costs detailed in Exhibit A are reasonable costs.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County that:

1. The costs claimed in Exhibit A are certified as just, correct, and reasonable; and no unnecessary or illegal item is claimed.
2. Payment of such costs in the amount of \$507.90 is approved.
