

RESOLUTION 2000 - 33

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2000 GENERAL FUND BUDGET TO RECEIVE UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE ST. JOHNS COUNTY SHERIFF'S DEPARTMENT.

WHEREAS, the County operating budget is annually prepared prior to knowing the actual amount of grant funds which may be received by the General Fund; and

WHEREAS, St. Johns County, Florida, when preparing the budget for Fiscal Year 2000, did not anticipate receiving grant funds from the State of Florida above and beyond those projected by the Sheriff's Department; and

WHEREAS, the State of Florida, Department of Community Affairs has made available additional grant dollars through the Bureau of Community Assistance for the implementation of a program dealing with the prevention of Domestic and Sexual Violence; and

WHEREAS, this program, known as the Florida STOP Violence Against Women Grant Program, will enhance the ability of the Sheriff's Office to deal with actions involving violence against women; and

WHEREAS, the State of Florida has grant funds to St. Johns County for Fiscal Year 2000 that exceeds budgeted grant amounts by \$122,914.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

1. The above "Whereas" statements are adopted as a finding of fact.
2. The General Fund revenue and expenditure budgets shall be adjusted to account for unanticipated funds from the State of Florida in the amount of \$122,914 for Fiscal Year 1999-2000.

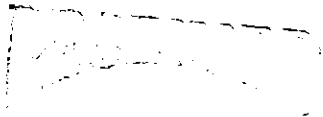
