**RESOLUTION BY THE BOARD OF COUNTY
COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA,
TO APPOINT A CITIZENS' ADVISORY TASK FORCE
FOR THE 2000 COMMUNITY DEVELOPMENT BLOCK
GRANT APPLICATION TO THE STATE OF FLORIDA,
AND FOR SUBSEQUENT CDBG APPLICATIONS.**

WHEREAS, on April 18, 2000, the Board of County Commissioners ("Board") of St. Johns County, Florida made known its intent to apply to the State of Florida for FFY 2000 Community Development Block Grant (CDBG) consideration under the provisions as set forth in Title I of the Housing and Community Development Act of 1974, as revised, by holding the first public hearing; and

WHEREAS, the Board desires to ensure citizen participation, including the input of its low and moderate income citizens.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

Section 1. The following people are appointed to serve on the Citizens' Advisory Task Force (CATF) for the 2000 CDBG application: Mr. Louis Howard, Rev. Nathaniel Jackson, Mrs. Diotha Bell, Mr. Leon Cooper, and Mrs. Cherrie McDougle (Exhibit A.)

Section 2. Rev. Major Highman, as a current member of the St. Johns County Housing Advisory Committee (HAC), is appointed as liaison to the CATF, representing the HAC.

Section 3. These citizens may serve as the CATF on future CDBG applications impacting West Augustine, until such time as the appointments are superseded by a later resolution.
