

RESOLUTION 2001 - 85

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2001 GENERAL FUND BUDGET TO RECEIVE UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE CIRCUIT COURT.

WHEREAS, the County operating budget is annually prepared prior to knowing the actual amount of grant funds which may be received by the General Fund; and

WHEREAS, St. Johns County, Florida, when preparing the budget for Fiscal Year 2001, did not anticipate receiving grant funds from the State of Florida above and beyond those projected by the Office of the Courts Administrator; and

WHEREAS, the State of Florida, Office of the State Courts Administrator has made available additional grant dollars through the Seventh Judicial Circuit for the implementation of a program dealing with Family Court issues; and

WHEREAS, this program, known as the Model Family Court Focus Grant Program, will enhance the ability of the Circuit Court to deal with actions involving families with the intention of reducing post litigation disputes and the preservation of families; and

WHEREAS, the State of Florida has grant funds to St. Johns County for Fiscal Year 2001 that exceeds budgeted grant amounts by \$30,000.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

1. The above "Whereas" statements are adopted as a finding of fact.
2. The General Fund revenue and expenditure budgets shall be adjusted to account for unanticipated funds from the State of Florida in the amount of \$30,000 for Fiscal Year 2000 - 2001.
