

RESOLUTION NO. 2002 - 160

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA AMENDING THE FISCAL YEAR 2002 GENERAL FUND REVENUE BUDGET TO RECEIVE UNANTICIPATED REVENUE FROM DONATIONS AND AUTHORIZE ITS EXPENDITURE BY THE ST. JOHNS COUNTY PLANNING DEPARTMENT.

WHEREAS, the St. Johns County Planning Department has received a donation in the amount of \$500.00 from the Florida East Coast Railway for the refurbishment of the St. Johns Railway historical marker located on CR 214; and

WHEREAS, because of the source being donations, these revenues were not anticipated during the preparation of the 2002 Fiscal Year Budget; and

WHEREAS, the St. Johns County Planning Department needs the recognition of those funds as current year revenues to enable their appropriation for their intended purposes;

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County that:

- 1. The above recitals are hereby adopted as findings of fact.
- 2. The General Fund revenue and expenditure budgets shall be adjusted to account for unanticipated funds from donations in the amount of \$500 for Fiscal Year 2002.

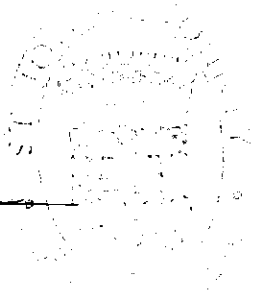

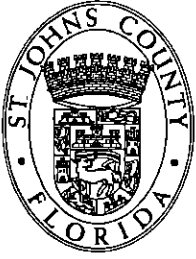
