

RESOLUTION NO. 2004 - 135

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE AMENDMENT OF ITS FY 2004 PARK CONSTRUCTION FUND BUDGET TO RECEIVE UNANTICIPATED REVENUE AND AUTHORIZED ITS EXPENDITURE BY THE ST. JOHNS COUNTY PARK CONSTRUCTION DEPARTMENT.**

**WHEREAS**, St. Johns County, Florida, when preparing its Park Construction Fund budget for fiscal year 2004, did not anticipate the receipt of funds from the Switzerland Volunteer Fire Department, and

**WHEREAS**, the funds are intended to be used for improvements to the Alpine Groves Park, and


**WHEREAS**, St. Johns County was given \$80,000 by the Switzerland Volunteer Fire Department for these improvements.

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, THAT:**


1. The above recitals are hereby adopted as legislative findings of fact.
2. The Park Construction Fund revenue and expenditure budgets shall be adjusted to account for unanticipated funds received from the Switzerland Volunteer Fire Department in the amount of \$80,000, for fiscal year 2004.

**PASSED AND ADOPTED** by the Board of County Commissioners of St. Johns County, State of Florida, this 15<sup>th</sup> day of June, 2004.

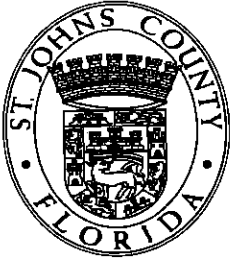
