

RESOLUTION 2004 - 196

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2004 LAW ENFORCEMENT TRUST FUND TO RECEIVE UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE ST. JOHNS COUNTY SHERIFF.

WHEREAS, the County operating budget is annually prepared prior to knowing the actual amount of funds which may be received by the Law Enforcement Trust Fund from the sale of confiscated property; and

WHEREAS, St. Johns County, Florida, when preparing the budget for Fiscal Year 2004, did not anticipate receiving funds from the sale of confiscated property above and beyond those projected; and

WHEREAS, the revenue from the sale of confiscated property for Fiscal Year 2004 amounts to \$16,993.93.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

1. The above recitals are hereby adopted as findings of fact.
2. The Law Enforcement Trust Fund revenue and expenditure budgets shall be adjusted to account for unanticipated funds from the sale of confiscated property and unclaimed funds in the amount of \$16,993.93 for Fiscal Year 2004.



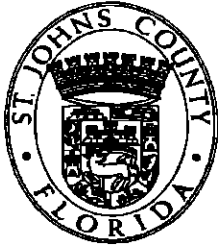
