**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA AUTHORIZING THE AMENDMENT OF THE 2004 ROAD & BRIDGE BUDGET TO RECOGNIZE UNANTICIPATED REVENUE FOR THE PUPROSE OF REPLACING A DAMAGED STREET LIGHT.**

**Whereas**, St. Johns County Florida, when preparing the Road & Bridge Budget for fiscal year 2004 did not anticipate the receipt of funds for a street light damaged by a vehicle; and

**Whereas**, after the accident the street light on US 1 south of SR 312 needs to be replaced; and

**Whereas**, St. Johns County was reimbursed \$3,728.75 by CNA, Continental Casualty Company for the replacement of the street light; and


**Whereas**, the Road & Bridge Department contractual services budget line item requires the addition of the insurance proceeds to contract for the replacement of the light.

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, THAT:**


- 1. The above recitals are hereby adopted as findings of fact.

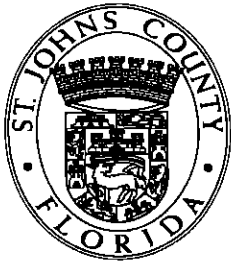
