

RESOLUTION 2004 - 64

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2004 TRANSPORTATION TRUST FUND BUDGET TO RECEIVE UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE ST. JOHNS COUNTY TRAFFIC & TRANSPORTATION DEPARTMENT.**

**WHEREAS**, the County operating budget is annually prepared prior to knowing the actual amount of Developer Contribution funds which may be received by the Transportation Trust Fund; and

**WHEREAS**, St. Johns County, Florida, when preparing the budget for Fiscal Year 2004, did not anticipate receiving Developer Contribution funds from The Hines Corporation; and


**WHEREAS**, the Developer has made available \$64,490 for the design and installation of a signal at the intersection of Palencia, International Golf Parkway and US 1.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:


1. The above recitals are hereby adopted as legislative findings of fact.
2. The Transportation Trust Fund revenue and expenditure budgets shall be adjusted to account for unanticipated funds from The Hines Corporation in the amount of \$64,490 for Fiscal Year 2004.

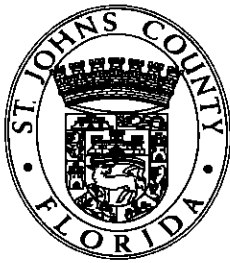
