

RESOLUTION NO. 2006-291

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING THE TERMS, PROVISIONS, CONDITIONS, AND REQUIREMENTS OF AN AMENDED AGREEMENT BETWEEN ST. JOHNS COUNTY, FLORIDA, AND EPIC COMMUNITY SERVICES FOR THE DRUG COURT PROGRAM, AUTHORIZING THE CHAIR OF THE BOARD OF COUNTY COMMISSIONERS TO EXECUTE THE AGREEMENT ON BEHALF OF THE COUNTY

WHEREAS, St. Johns County, Florida contracted with EPIC Community Services for the provision of services through the Drug Court Program; and

WHEREAS, the existing Contract contemplated that EPIC Community Services would provide 80 units of Initial Assessments, and 1457 units of Outpatient Counseling, or a total number of units of 1537 annually; and

WHEREAS, EPIC Community Services has requested the ability to revise the number of Initial Assessments to 42.25 units annually, and the number of Outpatient Counseling to 1494.75 units annually, with the total number of units remaining at 1537 annually, and with no additional funds being requested by EPIC Community Services; and

WHEREAS, the St. Johns County Government is providing grant funds to the EPIC Community Services which are to be disbursed by St. Johns County, Florida, in an amount not to exceed forty thousand dollars (\$109,127.00), for the purpose of providing funds for the Drug Court Program; and

WHEREAS, due to the nature of the Standard, Unit of Service Contract, executed by the parties, an Amendment to the Contract is necessary, in order to change the units of service; and

WHEREAS, an Amendment to the existing Contract has been attached hereto, and incorporated as Exhibit A to this Resolution; and

WHEREAS, the County has reviewed the terms, provisions, conditions, and requirements of the Amended Agreement; and

WHEREAS, the County has determined that accepting the terms of the Agreement, and entering into said Agreement will serve the interests of the County.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AS FOLLOWS:

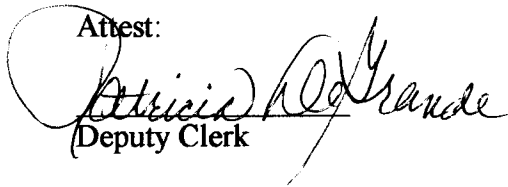
Section 1. The above Recitals are hereby incorporated into the body of this Resolution, and are adopted as Findings of Fact.

The Board of County Commissioners hereby approves the terms, provisions, conditions, and requirements of the Amended Agreement between the St. Johns County Government, Florida, and EPIC Community Services for the Drug Court Program and authorizes the Chair of the Board of County Commissioners to execute the Agreement on behalf of the County.

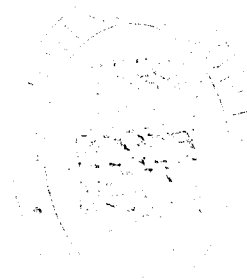

AMENDMENT TO CONTRACT BETWEEN EPIC COMMUNITY SERVICES AND
ST. JOHNS COUNTY BOARD OF COUNTY COMMISSIONERS

THIS AMENDMENT is to the Contract between EPIC Community Services (Provider) and the St. Johns County Board of County Commissioners (County), entered into and effective October 1, 2005 for the provision of services to residents of St. Johns County through the Drug Court Program.

WHEREAS, the County believes it to be in the public interest to provide certain activities to the residents of St. Johns County through the Provider according to the terms of the Contract; and

WHEREAS, the County and the Provider have agreed to amend the existing contract to include no additional funds but to reduce the Provider's stated number of remaining units for Initial Assessments, allowing the agency to use those units and funds for additional Outpatient Counseling services, so that the Provider may deliver additional units of service in the area of the program needed more;

WHEREAS, except for the reducing of specified, contracted units of services from the Initial Assessment area to 42.25 Total Units annually and increasing the Outpatient Counseling units to 1494.75 annually within the Drug Court Program, and with no increase of funds, the amendment of the contract shall be under the same terms, provisions, conditions, reporting, and requirements as are currently in place.

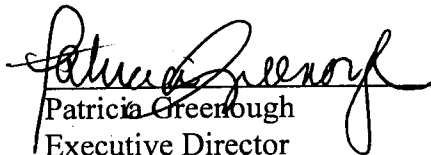
NOW THEREFORE, in consideration of the mutual promises set forth herein, the sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. The above recitals are hereby incorporated into the body of this Resolution, and are adopted as Findings of Fact.
2. Article III(A) The existing Contract between the St. Johns County Board of County Commissioners, and EPIC Community Services – Drug Court Program, is amended, as necessary, so as to note and reflect that the total units of service for Initial Assessments is reduced to 42.25 units annually. Article III(A) of the Contract, is also amended, as necessary, so as to note and reflect that the total units of service for Outpatient Counseling is increased to 1,494.75 units annually;
3. Contract Article III – A – Compensation and Reports of the Contract is amended, as necessary, so as to note and reflect that to reflect the total amount of the units of service through the Drug Court for Initial Assessments is 42.25 units at a cost of \$71.00 per unit. The total units of service for Outpatient Counseling shall be

1,494.75 annually at a cost of \$71.00 per unit. The total annual funding amount for the EPIC Community Services - Drug Court Program shall remain at \$109,127.00.

4. Exhibit 1 A Payment Request has been amended to reflect the change and is attached to this Amendment.
5. All other terms of the existing Contract remain in force and effect.

IN WITNESS THEREOF, the parties have caused this amendment to the existing contract to be executed by their undersigned officials as duly authorized.



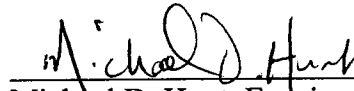
