

RESOLUTION NO. 2006-334

RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA ACCEPTING GRANTS OF DRAINAGE EASEMENT TO ALLOW ACCESS UNDER RAILROAD AVENUE TO INSTALL DRAINAGE CULVERTS AS PART OF THE WEST KING STREET IMPROVEMENT PROJECT.

RECITALS

WHEREAS, an owner of property (Block S, lot 21; Block T, lots 9 and 10) located adjacent to Railroad Avenue has executed and presented to the County, Grants of Drainage Easement, attached hereto as Exhibit "A" and Exhibit "B", incorporated by reference and made a part hereof; and

WHEREAS, the easements are needed for the West King Street Improvement Project to improve drainage in the West Augustine area; and

WHEREAS, these Grants of Drainage Easement will give the County the right to install and maintain drainage structures as needed at the Railroad Avenue and King Street intersection; and

WHEREAS, it is in the best interest of the County to accept these Grants of Drainage Easement to ensure proper drainage for the health, safety, and welfare of the citizens in that area.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as findings of fact.

Section 2. The Grants of Drainage Easement are hereby accepted in the form attached hereto.

Section 3. The Clerk is instructed to record the original Grants of Drainage Easement in the Official Records of St. Johns County, Florida.

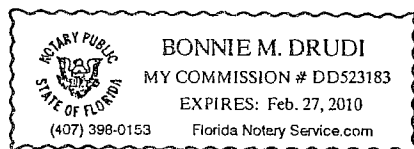

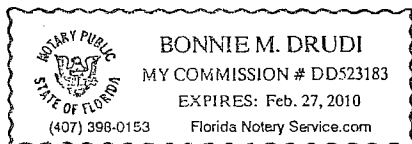

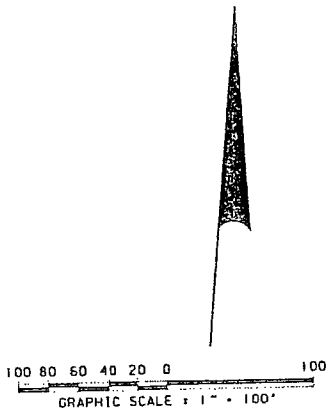
