**RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA APPROVING AND AMENDING SCHEDULE OF FEES FOR ONE COUNTY DEPARTMENT, AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the Board of County Commissioners of St. Johns County (the BCC), Florida is empowered to set fees relating to the provision of services provided by certain County Departments; and

WHEREAS, Resolution 2006-318, as amended, adopted the County Fee Schedule that County departments charge for specific services; and

WHEREAS, the Fee Schedule pertaining to Animal Control Fees needs to be revised to add a fee for animal microchipping; and

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that;

**Section 1. Approval of Fees and Charges**

The page of fees and charges that are attached hereto and made part hereof as Exhibit "A" are hereby adopted and replace the corresponding page in Resolution 2006-318, as amended. Any resolution provision in conflict with this change is hereby repealed and replaced to the extent of said conflict.

**Section 2. Effective Date**

This Resolution shall take effect on the 20th day of March 2007.
