

RESOLUTION NO: 2012 - 109

**A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO AWARD RFQ NO. 12-03 AND TO EXECUTE CONTINUING CONTRACT AGREEMENTS FOR SMALL SCALE CONSTRUCTION, RENOVATION AND REPAIR.**

**RECITALS**

**WHEREAS**, the County desires to enter into a contract with eleven (11) general contractors – Bush Construction Company, Inc, Thomas May Construction Company, VJ Usina Contracting, Inc, KP Meiring Company, Sauer, Inc, Mallen Construction, Inc, ABBA Construction, Inc, Charles Perry Construction, WW Gay Mechanical Contractor, Inc, ACON Construction Co., Inc, and Perry-McCall Construction, Inc, to provide general construction services under this contract; and to enter into a contract with sixteen (16) minor trades contractors – Burchfield Electric, Inc, Pure Air Controls Services, Kim’s Electric, Inc, WW Gay Mechanical Contractor, Inc, Taylor Refrigeration & Air Conditioning, Inc, B&S Signs, Inc, Kniceley Painting, Inc, Gruhn May, Inc, M. Gay Constructors, Inc, St. Johns Door & Window, Wilson Machine & Welding Works, Inc, RCI Windows & Doors, Dennis Shepherd Electric, Inc, Thibault’s Electrical Service, Inc, and Stanford Restoration to provide minor trades services under this contract; and

**WHEREAS**, the scope of the project shall consist of as needed general construction and minor trades services for projects located in St. Johns County; and

**WHEREAS**, through the County’s formal RFQ process, the above referenced eleven (11) general contractors and sixteen (16) minor trades contractors have been selected to enter into a contract with the County to perform the work referenced above; and

**WHEREAS**, the contract is being funded by the SJC Construction Services Department and

**WHEREAS**, the County has reviewed the terms, provisions, conditions and requirements of the draft contract (attached hereto, an incorporated herein) and finds that entering into the Contract serves a public purpose.

**NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA,** as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

Section 2. The County Administrator, or designee, is hereby authorized to award RFQ No. 12-03 to the above referenced eleven (11) general contractors and sixteen (16) minor trades contractors.

Section 3. The County Administrator, or designee, is further authorized to execute a contract which will be in substantial conformance with the attached draft contract for small scale construction, renovation and repair as specifically provided in RFQ No 12-03.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
