

RESOLUTION NO. 2012- 117

**A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING THE PROPOSED LOCATIONS OF ELEVEN BUS SHELTERS THROUGHOUT THE COUNTY.**

**RECITALS**

**WHEREAS**, the proposed bus shelter locations are attached hereto as Exhibit "A through G," incorporated by reference and made a part hereof, and are in connection with the St. Johns County Bus Shelter installation project; and

**WHEREAS**, Florida Department of Transportation has requested that a Resolution be adopted approving the locations at the library and State Road 312 due to a portion of the concrete pad being located in the state right-of-way. The City of St. Augustine will require an easement for the two locations on West King Street. The shelter on Granada Street required an easement from Flagler College which was approved at the March 20, 2012 Board meeting. All other locations are within County right-of-way. The construction of these shelters is funded by the Federal Transit Administration Grant #FL-90-X664; and

**WHEREAS**, it is in the best interest of the County to approve the proposed Bus Shelter locations for the safety and welfare of the citizens waiting for the bus; and

**WHEREAS**, to the extent that there are scrivener, typographical or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.



Section 1. The above recitals are incorporated by reference into the body of this Resolution and such recitals are adopted as findings of fact.


Section 2. The proposed locations attached and incorporated hereto, are hereby approved by the Board of County Commissioners.

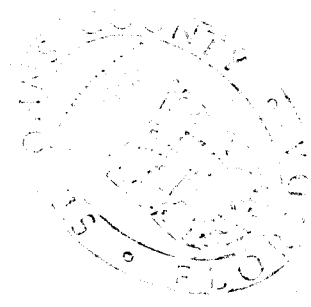

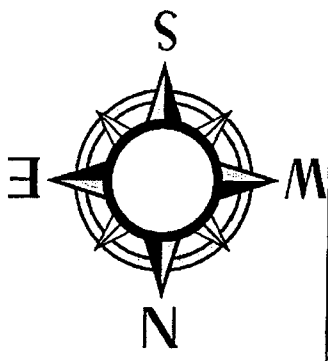

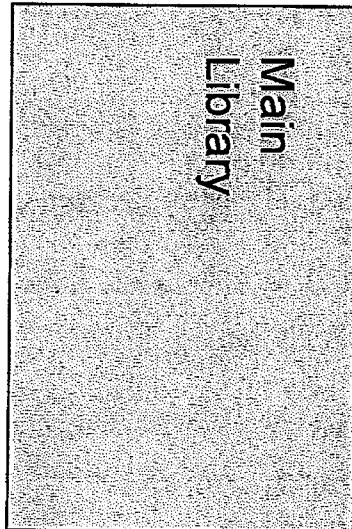
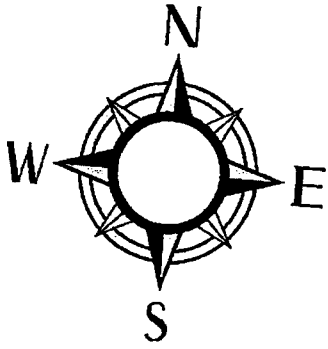

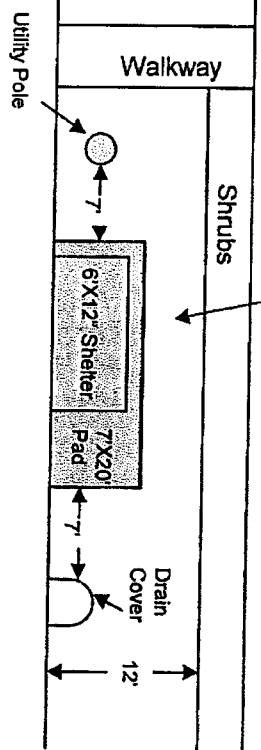

**2 - St Johns County Main Library (East Side)**

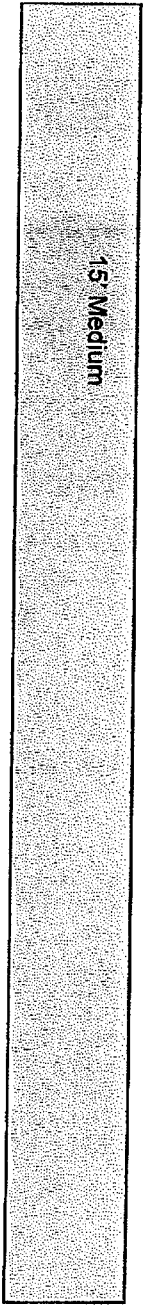

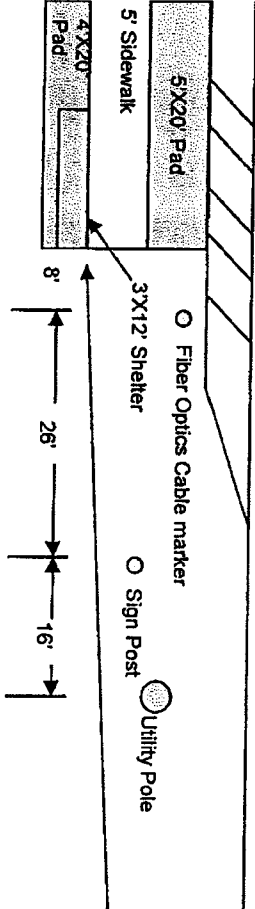

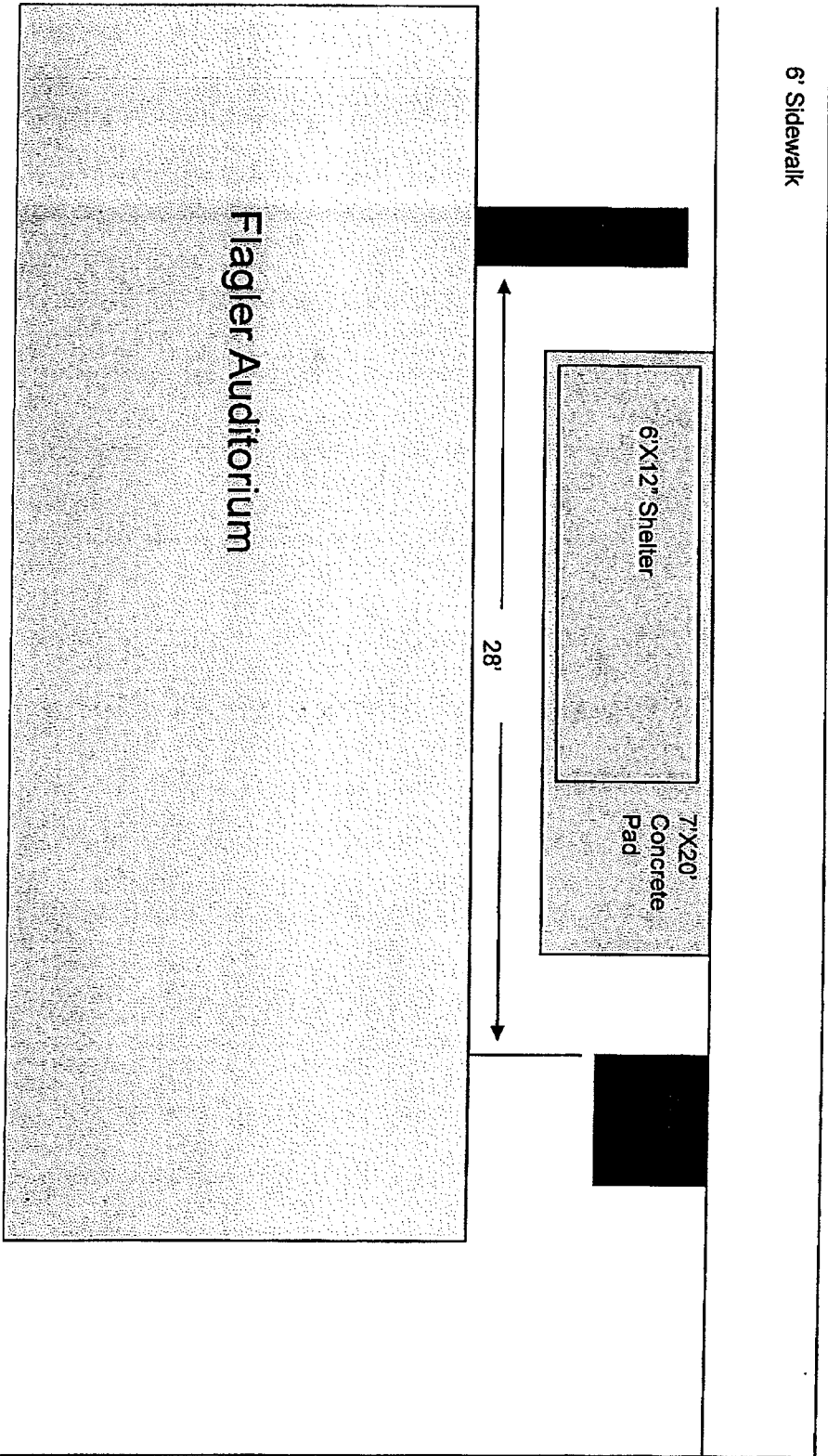

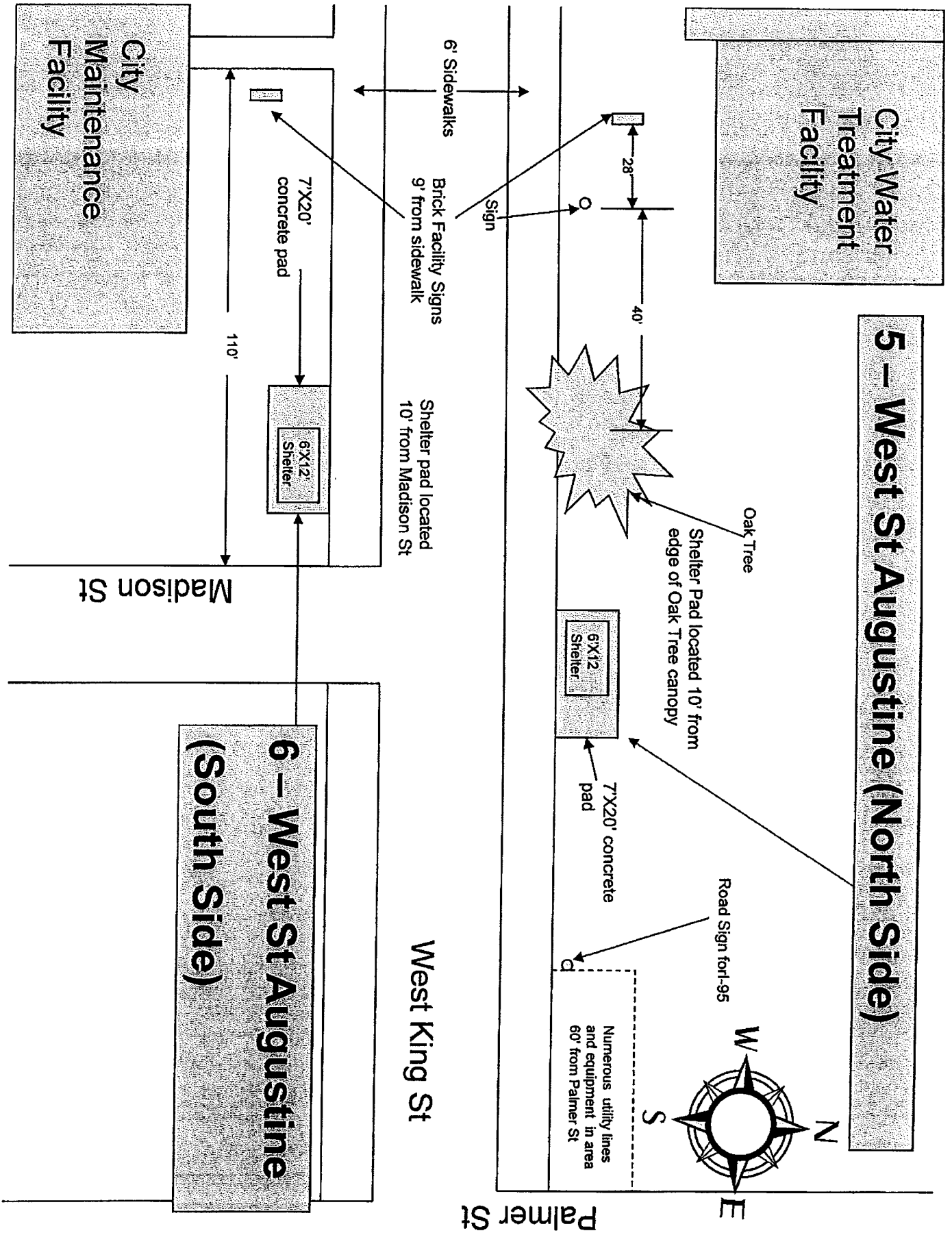
**3 - St Johns County Main Library (West Side)**

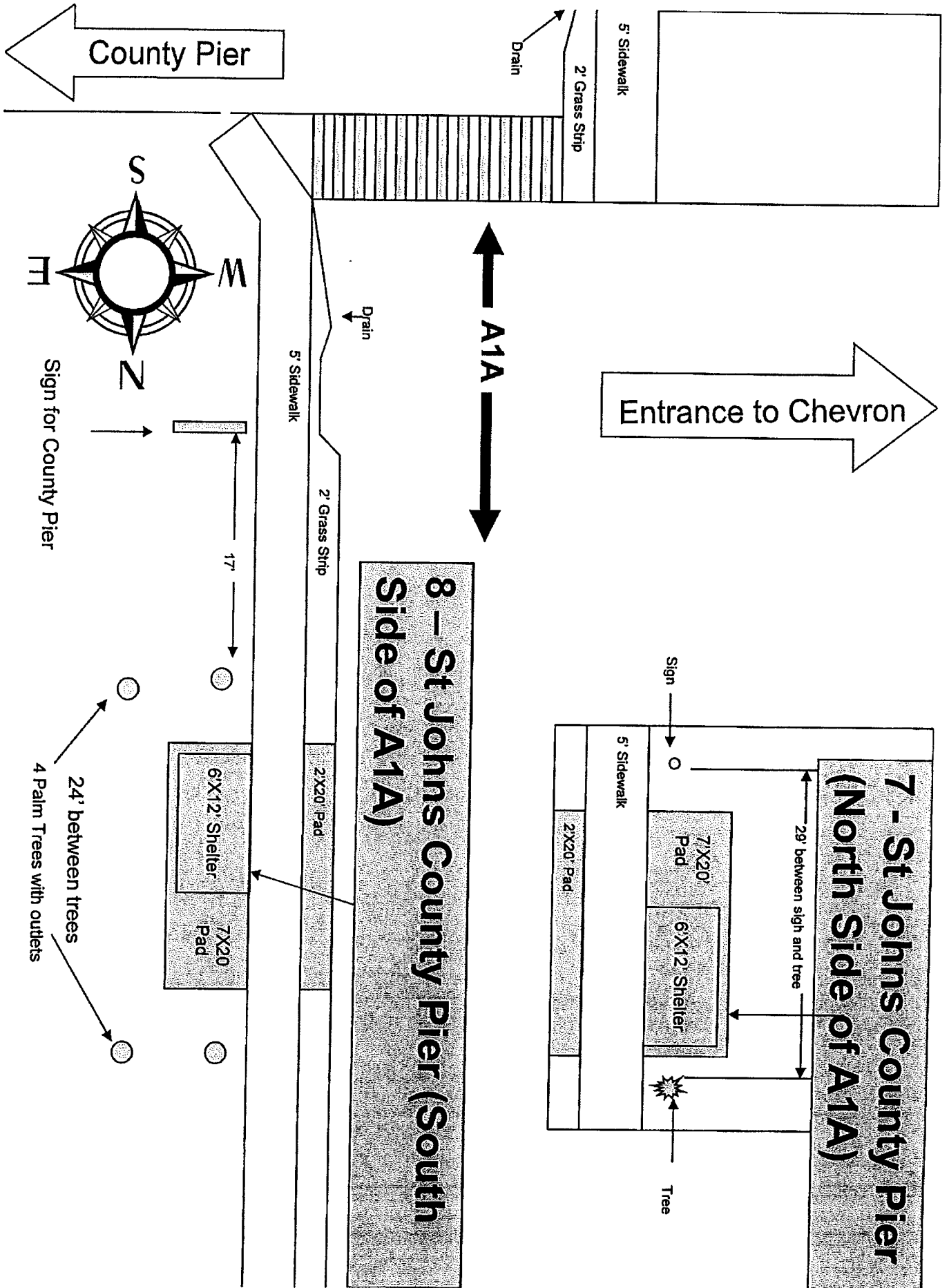

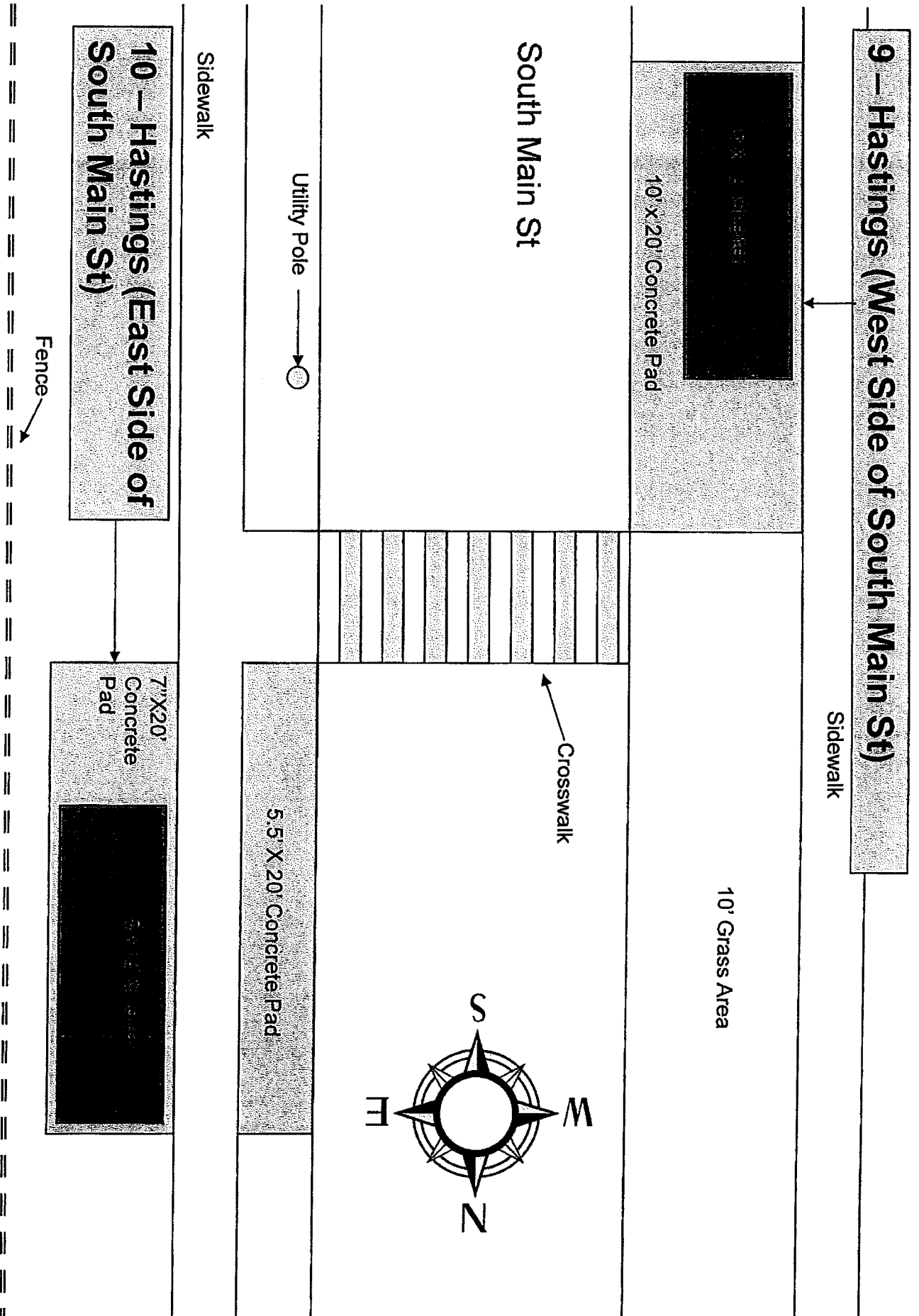
