

RESOLUTION NO. 2012- 149

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, A POLITICAL SUBDIVISION OF THE STATE OF FLORIDA, ESTABLISHING VOTER PRECINCTS WITHIN THE COUNTY.

WHEREAS, recent legislative, judicial actions relating to reapportionment, and the adoption of new district lines by the Board of County Commissioners of St. Johns County and the School Board of St. Johns County have resulted in the need to establish new election precincts; and

WHEREAS, Section 101.001, Florida Statutes, mandates precinct boundary changes; and

WHEREAS, the Board of County Commissioners of St. Johns County, Florida has determined that it is necessary to alter and change voter precincts within St. Johns County; and

WHEREAS, the Supervisor of Elections has requested, consented to, and approved of the altering and changing of voter precinct boundaries in St. Johns County, Florida in the manner hereinafter set forth; and

WHEREAS, Section 101.001 (3)(a)(b), Florida Statutes provides that the Supervisor of Elections shall provide, and maintain maps and word descriptions and shall provide certain public notice and notification to the Florida Secretary of State.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, that pursuant to Section 101.001, Florida Statutes, the voter precinct boundaries described in the exhibit attached hereto are hereby adopted; and

BE IT FURTHER RESOLVED, that the Supervisor of Elections of St. Johns County, Florida shall take all appropriate action to accomplish the requirements of Section 101.001 (3)(a)(b), Florida Statutes; and

BE IT FURTHER RESOLVED, that the Office of the Clerk of the Circuit Court of St. Johns County, Florida shall maintain a copy of the materials made available by the Supervisor of Elections pursuant to Section 101.001 (3)(a)(b), Florida Statutes, at the St. Johns County Courthouse and at the Office of the Clerk of the Board of County Commissioners.

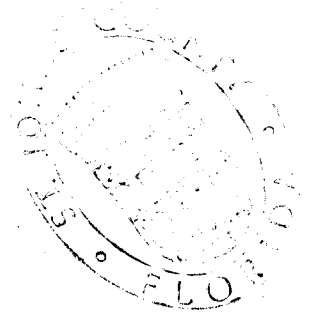

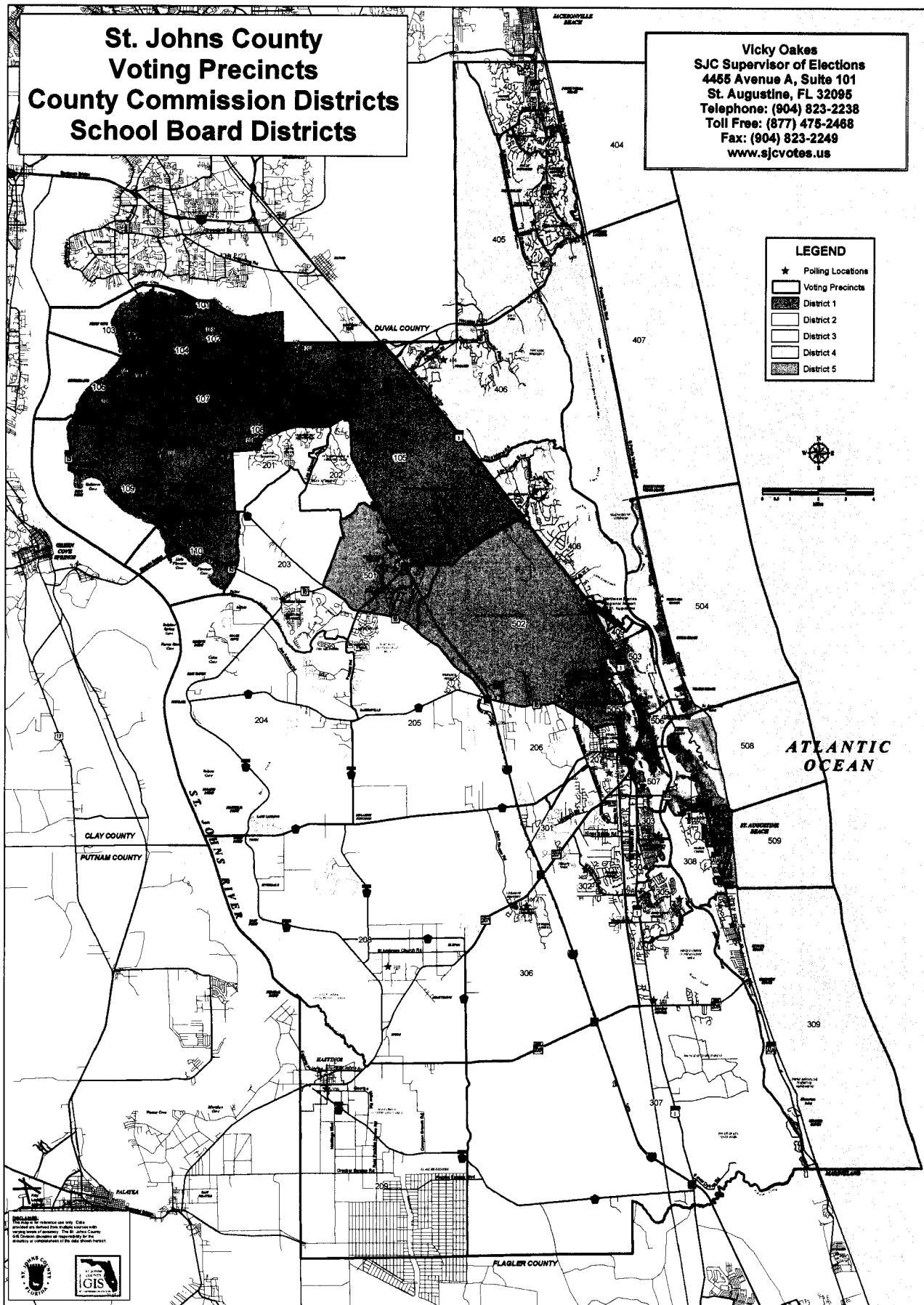
