

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO AWARD AND EXECUTE AN AGREEMENT FOR BID NO. 14-10 HAZARDOUS HOUSEHOLD WASTE COLLECTION SERVICES FOR THE SJC SOLID WASTE DEPARTMENT

RECITALS

WHEREAS, the County desires to enter into a contract with three (3) vendors: Perma-Fix of Florida, Inc, EQ Florida, Inc, and Tradebe Treatment & Recycling, LLC to perform hazardous household waste collection services for the SJC Solid Waste Department; and

WHEREAS, the scope of the project shall consist of performing collection services of materials classified as hazardous household waste for the SJC Solid Waste Department – Tillman Ridge Landfill on a twice weekly schedule, and additionally as needed based on the submitted and approved unit prices; and

WHEREAS, through the County’s formal bid process, Perma-Fix of Florida, Inc, EQ Florida, Inc, and Tradebe Treatment & Recycling, LLC were all lowest, responsive, responsible bidders, based on the categories and unit prices submitted, to enter into a contract with the County to perform the work referenced above; and

WHEREAS, the contract is being funded by the SJC Solid Waste Department; and

WHEREAS, the County has reviewed the terms, provisions, conditions and requirements of the Contract (attached hereto, an incorporated herein) and finds that entering into the Contract serves a public purpose.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

Section 2. The County Administrator, or designee, is hereby authorized to award Bid No. 14-10 to Perma-Fix of Florida, Inc, EQ Florida, Inc, and Tradebe Treatment & Recycling, LLC.

Section 3. The County Administrator, or designee, is further authorized to execute the attached Contract with the three (3) stated vendors on behalf of the County for hazardous household waste collection services as specifically provided in the Bid Documents for Bid No 14-10.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
