RECITALS

WHEREAS, Big Splash Restaurant Group, LLC, a Florida Limited Liability company, has executed and presented to the County a Bill of Sale and Schedule of Values, attached hereto as Exhibit "A," incorporated by reference and made a part hereof, conveying all personal property associated with the water and sewer lines to serve Salt Life Restaurant on A1A Beach Boulevard; and

WHEREAS, the water and sewer lines have been installed within public right-of-way therefore no utility easement is needed; and

Section 4. The Clerk of Court is instructed to file the Bill of Sale and Schedule of Values in the public records of St. Johns County, Florida.
