

RESOLUTION NO. 2016- 27

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, ACCEPTING A GRANT OF DRAINAGE EASEMENT FOR DRAINAGE IMPROVEMENTS ALONG PONTE VEDRA BOULEVARD.

RECITALS

WHEREAS, Timothy and Karen Slater have executed and presented a Grant of Drainage Easement to St. Johns County ("County"), attached hereto as Exhibit "A", incorporated by reference and made a part hereof, and

WHEREAS, the Grant of Drainage Easement will allow the County to perform drainage improvements and future maintenance to a drainage ditch located within the easement area; and

WHEREAS, it is in the best interest of the County to accept the easement for the purposes mentioned above as the improvements will help alleviate some of the drainage issues in that area.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated into the body of this Resolution and such Recitals are adopted as findings of fact.

Section 2. The Board of County Commissioners hereby accepts the Grant of Drainage Easement.

Section 3. The Clerk is instructed to record the original Grant of Drainage Easement in the Public Records of St. Johns County, Florida.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

GRANT OF DRAINAGE EASEMENT

THIS INDENTURE, made this 6th day of January, 2016, between **TIMOTHY J. SLATER and KAREN A. SLATER**, husband and wife, whose address is 1086 Ponte Vedra Boulevard, Ponte Vedra Beach, Florida 32082, hereinafter called Grantors, and **ST. JOHNS COUNTY, FLORIDA**, a political subdivision of the State of Florida, whose address is 500 San Sebastian View, St. Augustine, Florida 32084, hereinafter called Grantee.

WITNESSETH: That Grantors, for and in consideration of the benefit that Grantors will receive, the receipt of which is hereby acknowledged, have granted and conveyed to the Grantee, its successors and assigns, an ingress and egress easement with the right, privilege, and authority to said Grantee, its successors and assigns, to drain surface waters either above or below the surface of the ground, together with the right to install and maintain drainage structures, on, along, over, through, across, or under the following described land situate in St. Johns County, Florida to wit:

TOGETHER with the right of said Grantee, its successors and assigns, of ingress and egress, to and over said above described premises, and for doing anything necessary or useful or convenient, or removing at any time and all of said improvements upon, over, under, or in said lands, together also with the right and easement, privileges, and appurtenances in and to said land which may be required for the enjoyment of rights herein granted.

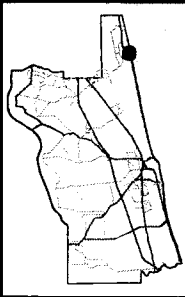
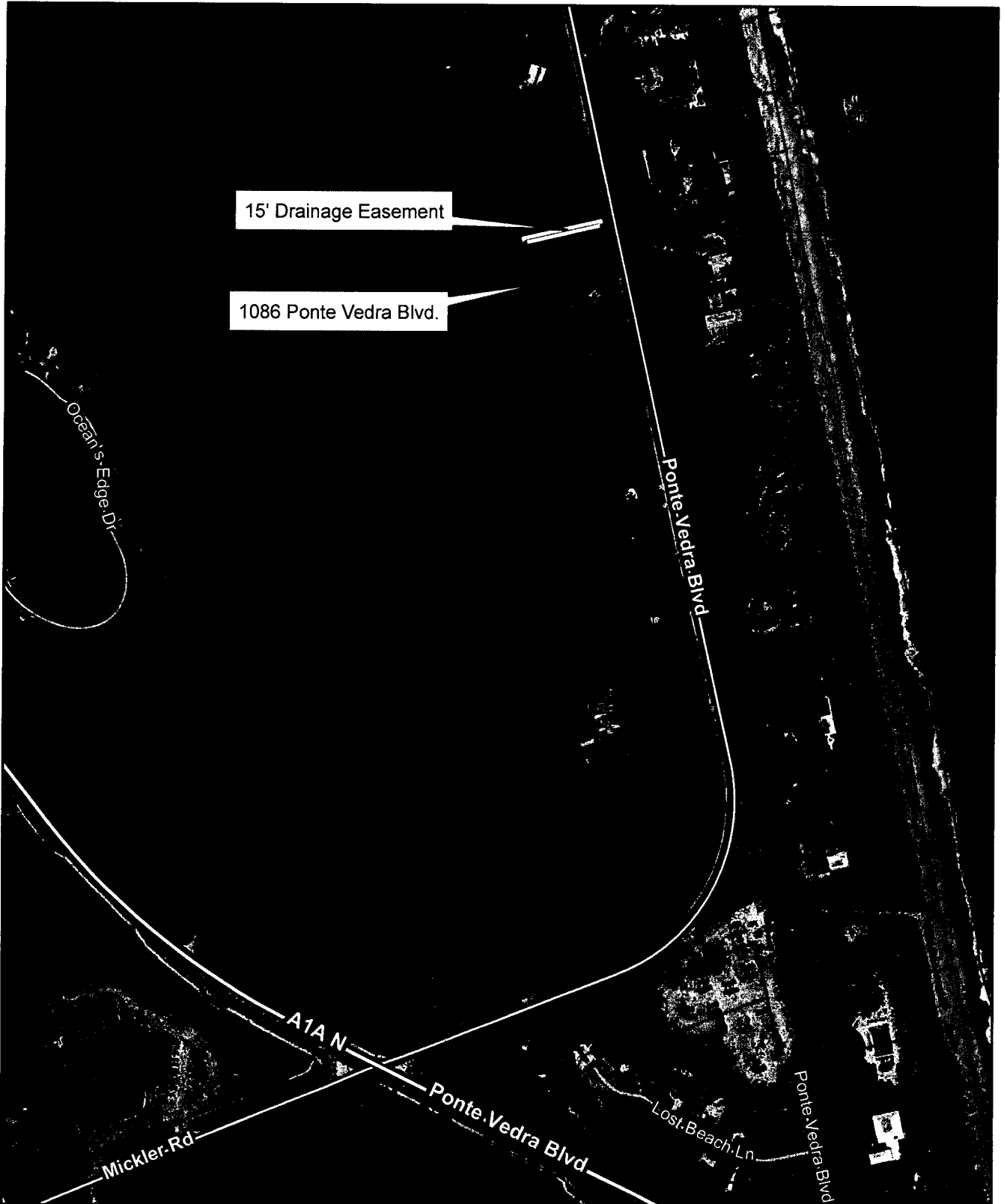
