

RESOLUTION NO. 2019- 197

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING AN INCREASE IN THE COST OF A SUNSHINE BUS COMPANY REGULAR FARE FOR THE FIXED ROUTE SYSTEM FROM \$1.00 TO \$2.00, AND DAILY PASS FARES FROM \$2.00 to \$4.00.**

WHEREAS, the Council on Aging operates the Sunshine Bus Company, a public transportation system that serves all residents of St. Johns County; and

WHEREAS, the Council on Aging collects fares as the County's designated fixed route operator; and

WHEREAS, the Council on Aging requests an increase in the regular fare from \$1.00 to \$2.00, and the cost for the elderly and students will increase from \$.50 per ride to \$1.00; and

WHEREAS, the Council on Aging also requests an increase in the daily pass from \$2.00 to \$4.00, and the cost for discounted daily passes will increase from \$1.00 per ride to \$2.00; and

WHEREAS, in accordance with the approved Public Participation process for Federal Transit Administration Section 5307 program funding any fare increases must be approved following two advertised public hearings; and

WHEREAS, the first public meeting regarding a fare increase was provided at the St. Johns County Transportation Disadvantaged Local Coordinating Board on June 4, 2019; and

WHEREAS, this second and final public meeting on the fare increase has been conducted at an advertised Board of County Commissioners meeting on June 18, 2019; and

NOW, THEREFORE, BE IT RESOLVED BY THE ST. JOHNS COUNTY BOARD OF COUNTY COMMISSIONERS THAT:

1. The above recitals are incorporated into the body of this resolution, and such Recitals are adopted as Findings of Fact.
2. In accordance with the approved Public Participation process for Federal Transit Administration Section 5307 program funding, the monthly pass increase was approved by the St. Johns County Transportation Disadvantaged Local Coordinating Board during an advertised public meeting

3. The Board of County Commissioners approves of the increase in the cost of the Sunshine Bus regular fare from \$1.00 to \$2.00, and the increase in discounted fares from \$.50 to \$1.00.

4. The Board of County Commissioners approves of the increase in the cost of the Sunshine Bus daily pass from \$2.00 to \$4.00, and the increase in discounted passes from \$1.00 to \$2.00.

5. To the extent that there are typographical or administrative errors that do not change the tenor, or concept of this resolution, then this resolution may be revised without subsequent approval of the Board of County Commissioners.

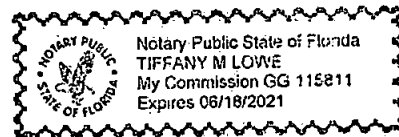
