

RESOLUTION NO. 2019- 229

**A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, IN SUPPORT OF HOUSE BILL 0385 DESIGNATING A PORTION OF INTERSTATE 95 IN ST. JOHNS COUNTY AS "TROOPER WILBURN A. KELLY MEMORIAL HIGHWAY".**

**RECITALS**

**WHEREAS**, during the 2019 Legislative Session, the Florida Legislature passed House Bill 0385, which makes honorary designations of transportation facilities through Florida and directs the Florida Department of Transportation to erect suitable markers for those designations; and

**WHEREAS**, House Bill 0385 designates that portion of Interstate 95 between mile marker 332 and mile marker 327 in St. Johns County as "Trooper Wilburn A. Kelly Memorial Highway"; and

**WHEREAS**, Section 334.071, Florida Statutes, provides that a city or county must pass a resolution in support of a particular designation before road markers are erected; and

**WHEREAS**, St. Johns County wishes to honor Trooper Wilburn A. Kelly and requests that the Florida Department of Transportation erect suitable markers designating a portion of Interstate 95 between mile marker 332 and mile marker 327 in St. Johns County as "Trooper Wilburn A. Kelly Memorial Highway".

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, as follows:

Section 1. The above Recitals are incorporated into the body of this Resolution and such Recitals are adopted as findings of fact.


Section 2. The Board of County Commissioners strongly supports House Bill 0385, and designation of a portion of Interstate 95 in St. Johns County between mile marker 332 and mile marker 327 as the "Trooper Wilburn A. Kelly Memorial Highway".

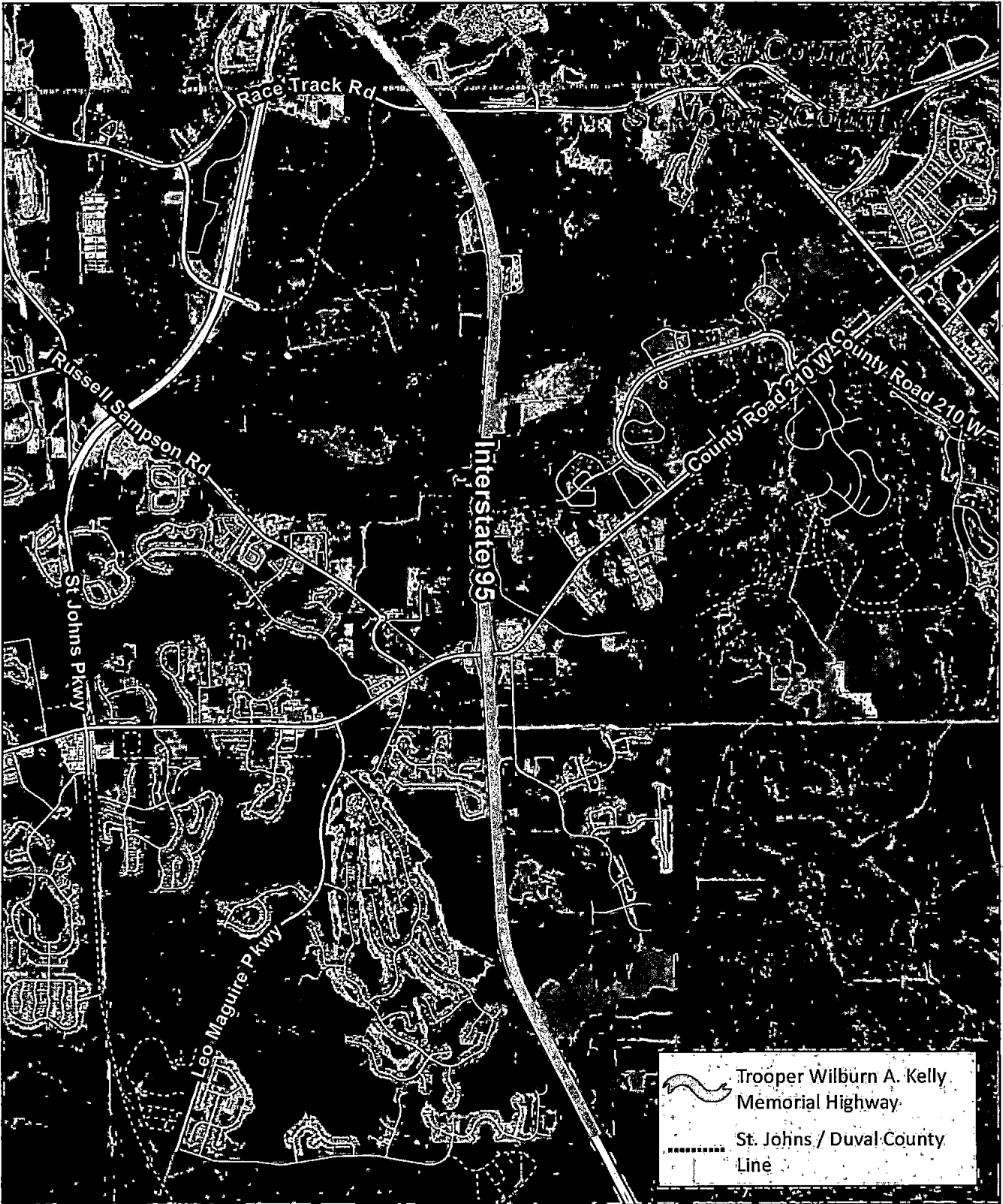



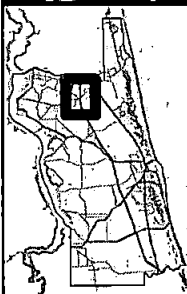
