

RESOLUTION NO. 2020-275

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE CHAIR OF THE BOARD OR HIS DESIGNEE TO SIGN AND SUBMIT THE FUNDING APPROVAL/AGREEMENT AND A SCHEDULE OF INDIRECT COST RATES TO RECEIVE \$585,519 IN SUPPLEMENTAL COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS, TITLED CDBG-CV, FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT.

RECITALS

WHEREAS, the County prepared a 2016-2020 Consolidated Plan and a 2019-2020 Action Plan for the purpose of submitting an application for Community Development Block Grant (CDBG) entitlement funding through the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, HUD has awarded the County a 2019 CDBG grant, in the amount of \$930,264, to assist the County in providing benefits to low and moderate income residents in accordance with the 2016-2020 Consolidated Plan; and

WHEREAS, the Coronavirus Aid, Relief and Economic Security Act (CARES Act) has made available supplemental grant funding in the amount of \$585,519 to the County through a CDBG-CV award, to be used to prevent, prepare for, and respond to COVID-19; and

WHEREAS, HUD required the County to apply for this CDBG-CV funding through an amendment to the 2019-2020 Annual Action Plan, which was approved by Resolution 2020-152; and

WHEREAS, the County recognized and appropriated CDBG-CV of \$585,519 within the Fiscal Year 2020 budget with Resolution 2020-152; and


WHEREAS, the County must now submit HUD form 7082, which is the Funding Approval/Agreement for CDBG-CV and an accompanying schedule of indirect cost rates, so that the County can proceed with using CDBG-CV funds to respond to the COVID-19 crisis as specified in the amended 2019-2020 Annual Action Plan.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY:

1. The above recitals are incorporated by reference into the body of this resolution and such recitals are adopted as findings of fact.
2. The Board of County Commissioners authorizes the Chair to sign HUD-7082 Funding Approval/Agreement for CDBG-CV funds.
3. The Board of County Commissioners authorizes the County Administrator, or his designee, to submit to HUD the signed HUD-7082 Funding Approval/Agreement for CDBG-CV and a schedule of indirect cost rates.
4. To the extent that there are typographical or administrative errors or omissions that do not change the tone, tenor, or context of this resolution, this resolution may be revised without subsequent approval of the Board of County Commissioners.
5. This resolution shall become effective immediately upon adoption.

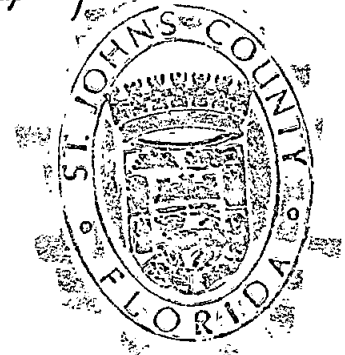
