

**RESOLUTION NO. 2021-354**

**A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, RECOGNIZING AND APPROPRIATING THE U.S. SMALL BUSINESS ADMINISTRATION SHUTTERED VENUE GRANT WITHIN THE FISCAL YEAR 2021 CULTURAL EVENTS FUND BUDGET.**

Recitals:

WHEREAS, on February 16, 2021, the St. Johns County Board of County Commissioners approved the application to the United States Small Business Administration for a Shuttered Venue Operators Grant, providing economic aid to venues impacted by COVID-19; and

WHEREAS, on July 27, 2021, the United States Small Business Administration awarded a Shuttered Venue Operators Grant to the St. Johns County Cultural Events Division in the amount of \$5,984,568; and

WHEREAS, on August 3, 2021, the St. Johns County Board of County Commissioners executed the Notice of Award for the \$5,984,568 grant; and

WHEREAS, the \$5,984,568 Shuttered Venue Operators Grant was not appropriated within the Fiscal Year 2021 Budget adopted by the Board of County Commissioners and will need to be recognized and appropriated within the Cultural Events Fund.


**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:
