

RESOLUTION NO. 2024-442

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, ACCEPTING A BILL OF SALE AND FINAL RELEASE OF LIEN ASSOCIATED WITH THE WATER REUSE SYSTEM TO SERVE BEACON LAKE PHASE 2A.

RECITALS

WHEREAS, The Meadow View at Twin Creeks, a community development district, has executed and presented to the County a Bill of Sale with a Schedule of Values, attached hereto as Exhibit "A", incorporated by reference and made a part hereof, conveying all personal property associated with the water reuse system to serve Beacon Lake Phase 2A; and

WHEREAS, Hughes Brothers Construction, Inc., a Florida profit corporation, has executed and presented to the County a Final Release of Lien for work performed at Beacon Lake Phase 2A, attached hereto as Exhibit "B", incorporated by reference and made a part hereof; and

WHEREAS, St. Johns County Utility Department has reviewed and approved the documents mentioned above, as stated in a memo attached hereto as Exhibit "C", incorporated by reference and made a part hereof.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above recitals are incorporated by reference into the body of this Resolution and such recitals are adopted as findings of fact.


Section 2. The above described Bill of Sale and Final Release of Lien, attached and incorporated hereto, are hereby accepted by the Board of County Commissioners.



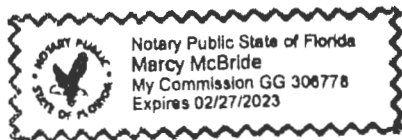
